COMMISSION AGREEMENT

Verdict: \$86,544

Real estate agent sought payment for commissions owed on sales (*Pompei v. Premier Props. of Mesquite*, Clark Co. Dist. Ct., Plaintiff attorney: Bo Bingham).

EMPLOYMENT DISCRIMINATION

Settlement: \$457,500

African-American employees claimed verbal harassment constituted racial discrimination (*Equal Employment Opportunity Comm'n v. N-M Ventures*, U.S.D.C., D. Nev., Plaintiff attorney: Anna Y. Park).

DOOR MALFUNCTION

Settlement: \$100,000

Falling garage door injures tenant (*Velasco v. Dunn*, Clark Co. Dist. Ct., Plaintiff attorney: David D. Boehrer).

DRUNK DRIVER

Decision: \$280,252
