NEVADA LAWYERS ASSISTANCE REPORT

YLS REPORT

Scott Lachman reported on the recent activities of the Young Lawyers Section (YLS). Mr. Lachman gave a synopsis on the 2019 Trial Academy. The 2019 theme is criminal law. The YLS goal is to have 30 members attend the academy. Mr. Lachman discussed making the YLS dues an opt out option.

ACTION ITEMS

ADKT Limited Practice Certification

Ann Morgan presented a report on the proposed Limited Admission Certifications ADKT. After approving the proposed ADKT at the Board of Governors meeting in September, the Reciprocity Taskforce reviewed the ADKT to address additional matters that are included in the proposed ADKT. Barbara Buckley, Executive Director of Legal Aid Center of Southern Nevada (LACSN) reported on the concerns that LACSN has with the proposed changes to rule 49.2 (Emeritus Pro Bono) and 72.1 (Legal Services). Ms. Buckley highlighted that if these changes go into effect, it will hinder the recruitment of attorneys willing to work for Legal Services.

After much discussion, it was moved, seconded and carried to authorize the revision of the ADKT Limited Practice Certifications as presented but with a carve out for rule 49.2 and 72.1.

Financial Report

Marc Mersol gave an overview of the 2019 proposed budget. It was moved, seconded and carried to approve the 2019 proposed budget for the State Bar of Nevada.

Audit Report

Daniel McArthur explained the audit process and 2017 audit report. The Audit Committee moved and the Board approved acceptance of the 2017 Audit Report. After the audit report presentation, the Board entered Executive Session with the auditor at 11:50 am and concluded at 12:05 pm. All staff were excused while the auditors met with the Board of Governors.

E-newsletters Advertising

The state bar's Publications department proposed redesigning the state bar's weekly eNews publication into a mobile-device-friendly format and a proposal to accept advertising in the eNews. It was moved, seconded and carried to approve the eNews proposal to redesign and accept advertising.

Renewal Quest Lease Agreement

The first floor space at 3100 W. Charleston is leased by Quest Diagnostics. The lease expires on January 31, 2019. Quest is asking for a one-year lease renewal. It was moved, seconded and carried to negotiate the lease renewal within the parameters presented to the Board.
