#### **CALL TO ORDER**

President Bryan Scott called the meeting to order with a quorum present at 8:45 am.

### **PRESIDENT'S REPORT**

Bryan Scott presented highlights of the Opening Ceremony of the new Supreme Court building in Las Vegas. Mr. Scott thanked all who were involved in making the event a success.

Mr. Scott updated the Board members on the Supreme Court committee charged with review of matters pertaining the Nevada Bar Exam.

### **DISCUSSION**

#### Trust Account Audits

Kim Farmer provided a report covering options for audits to attorney trust accounts. It was moved, seconded and carried to establish a taskforce to study the issue of random trust account audits. Taskforce members are Richard Dreitzer, chair, Paola Armeni, Jack Howard, Gene Leverty and Ryan Works.

## o We the People/Center for Civic Engagement Proposal

Kim Farmer presented an overview of the We the People (WTP) program and the proposal from the Center for Civic Education (CCE). The CCE proposal seeks to take over the management of the We the People program and further develop the expansion to elementary and middle schools.

Upon discussion it was moved, seconded and carried to keep the We the People program with the state bar with focus solely on the high school WTP component and to create a We the People Committee. It was moved seconded and carried to sunset the Law Related Education Committee.

# Clients' Security Fund Report

The Budget Committee provided a report on the status of the Client Security Fund (CSF) and the impact upcoming claims will have on the CSF. It was moved and carried to accept the recommendation of the Budget Committee to rescind the Board's December 2016 action that transferred \$50,000 to the Nevada Lawyers Assistance Program from CSF reserves and the action that held the transfer of the \$25 per active member dues from attorney license fees to the CSF.

## **ACTION ITEMS**

#### **Financial Report**

Marc Mersol reviewed the Financial Operations as of February 28, 2017. It was moved, seconded and carried to accept the Financial Operations report as of February 28, 2017.

## LRIS Grant Program (LRIS)

Kim Farmer presented an overview of the LRIS Public Service Grants Program and the current formula used to determine funds available for granting. Based on declining funds available for granting, Ms. Farmer asked the Board to consider a revised granting formula for 2017 to grant additional funds from the LRIS designated reserve fund. It was moved, seconded and carried to combine the LRIS granting fund and designated fund into one granting fund. And to approve \$50,000 for 2017 grants. And that the funding amounts for the LRIS grants will be considered on an annual basis based on funds available.

### **New Member Benefit**

Kim Farmer provided an overview of the proposal from National Purchasing Partners for a member benefit that offers discounted services from national brands. It was moved, seconded and carried to approve the partnership with National Purchasing Partners.

She also discussed the proposal from Ruby Receptionists, a virtual receptionist service system to provide a member benefit program. It was moved, seconded and carried to approve the partnership with Ruby Receptionists.

#### **SECTION REPORTS**

### Young Lawyers Section

Kim Farmer reviewed the recent activities of the Young Lawyers Section (YLS). YLS paired up with Nevada Legal Services to hold two ask-a-lawyer sessions for flood victims in northern Nevada. YLS also has two pro bono events on the horizon: Serving Seniors clinic and Project Salute's Armed Services Day clinic.

o ADR Section Report, Richard Pocker

Richard Pocker gave an overview on the ADR section meeting he recently attended. Mr. Pocker encouraged Board members to attend section meetings.

# **TASKFORCE REPORTS**

### o Reciprocity Taskforce

Ann Morgan provided an overview of the recent meeting of the reciprocity taskforce. The taskforce focused

on the four avenues an attorney can be admitted to practice law in Nevada without taking the Nevada bar exam:

- 1. Transfer of bar exam scores The transfer of scores can be related to the Uniform Bar Exam (UBE) or other bar exam scores for those jurisdictions not offering the UBE. The Taskforce determined that their focus will be on transfer of bar exam scores only. The Taskforce will not consider whether Nevada should use the UBE to replace the current Nevada bar exam.
- 2. Attorney examination this is considered and alternate bar exam. Other jurisdictions use a bar exam, typically shorter than the "standard" bar exam for attorneys seeking licensure in a state.
- 3. Admission by Motion an attorney can apply to be admitted.
- 4. Limited License Certifications These are the certifications provided under SCR 49.

The Taskforce plans to look at each of the four avenues that provides for an attorney to gain admission to practice in Nevada (without taking the Nevada bar exam) and thoroughly research the pros and cons of each.

#### Juvenile Justice Taskforce

Julie Cavanaugh-Bill reported on the Juvenile Justice Taskforce meeting. Taskforce members have been working on practice standards for the last several months and have developed a set of rules that are currently being revised and reviewed for future possible voluntary specialty certification or for future possible required rules of practice.
