CALL TO ORDER

President Rick Pocker called the meeting to order with a quorum present at 11:00 am.

PRESIDENT'S REPORT

Mr. Pocker reviewed the Supreme Court Order amending SCR 106.5 to define the state bar's two attorney wellness programs Lawyers Concerned for Lawyers and the Nevada Lawyer Assistance Program (NLAP) that included NLAP under the Rule's confidentiality and immunity provisions. Mr. Pocker also provided and overview of the Western States Bar Conference. The conference program focused on issues affecting mandatory state bars and programing discussion on attorney wellness.

PRESIDENT-ELECT REPORT

Paul Matteoni reported on ABA Day, Washington, DC. Mr. Matteoni met with most of Nevada's elected officials in the House and Senate to discuss matters approved by the BOG – funding for legal services and public service loan forgiveness.

EXECUTIVE DIRECTOR REPORT

Kimberly Farmer discussed the annual awards presented by the State Bar with a review of how the winners are chosen. The awards are presented at the State Bar Annual Meeting in June.

Ms. Farmer reviewed the plans to host a wellness summit in the fall. The summit is designed as a forum for leaders in the profession to discuss issues affecting Nevada lawyers such as mental health and addiction. Ms. Farmer reported on the recent podcasts that cover the revisions to Nevada's Rules for Civil Procedure.

DISCUSSION

Fee Assessment - Suspended Attorney Policy

Kimberly Farmer reviewed the current policy of when attorneys are suspended from practice in Nevada. Attorneys who are suspended do not pay license fees during the time of their suspension and they do not pay accrued fees at the time of their reinstatement. The exception is with attorneys who are reinstated after a license fee suspension; those attorneys must pay all accrued license fees, late fees, and penalties for each year delinquent. Ms. Farmer discussed policies in other jurisdictions.

After much discussion, it was moved, seconded, and carried to implement a policy requiring those seeking reinstatement from a suspension (discipline, CLE and administratively) to pay a fee equivalent to inactive fees for each year suspended. This policy becomes effective January 1, 2020. For those suspended as of this date, going forward, they will be required to pay the accrued annual fee upon reinstatement.

Section CLE Split Policy

Kimberly Farmer discussed the Section CLE Policy. Ms. Farmer noted that each section varies their CLE programs in terms of the registration price, CLE topic, number of complimentary registrations, lunches, and other expenses. Those sections with a smaller member counts are having difficulty with the CLE fee charged by the bar. After discussion, it was moved, seconded, and carried to wave the administrative fee for sections with a membership of fewer than 50 members.

EXECUTIVE SESSION

Eric Dobberstein discussed his recent trip to Cuba with Cultural Travel/CLE Abroad emphasizing the educational component of the trip and the quality of the programming and of the accommodations. It was moved, seconded, and carried to offer the Cultural Travel/CLE Abroad space in Nevada Lawyer and the e-news to advertise an education program hosted solely by Cuba with Cultural Travel/CLE Abroad.

Resolution-Broadband

The Colorado Bar Association (CBA) requested support from the state bar associations on a resolution regarding the need to expand broadband in the United States. The CBA plans to introduce the resolution at the House of Delegates meeting during the American Bar Association's Annual meeting. The Resolution urges Congress, state, and local legislatures to enact legislation an appropriate funding to deploy broadband infrastructure. It was moved, seconded, and carried to support the Resolution with a letter of support.
