DISCUSSION

Bar Exam Survey

Rick Trachok presented a review of pros and cons of conducting the July Bar Exam only in Las Vegas. The Board of Bar Examiners is not taking a position on this issue. Mr. Trachok also discussed the concept of a study designed to survey attorneys who have been admitted to practice in Nevada within the past 5 years who will complete the survey and then volunteer to have their peers and/or supervisors evaluate their skills which are believed to be critical to the practice of law.

Discipline Report/Structure

Dan Hooge presented the report and statistics covering matters in the Office of Bar Counsel (OBC).

The Board discussed the discipline structure and alternatives. After discussion President Pocker and President-elect Matteoni determined that a taskforce should be appointed charged with review of the discipline panel structure and alternatives. Reciprocity Taskforce

Ann Morgan reviewed the status of ADKT 0538 amending Limited Practice Certifications.

Ms. Morgan reminded the BOG of one of the identified goals of the 2018-2020 Board of Governors Strategic Plan is to advance a position on reciprocity. Next on the list of key measurables is to encourage discussion and feedback from Nevada attorneys about reciprocity. A survey regarding reciprocity was sent to Nevada attorneys with active, active exempt and inactive status. The reciprocity taskforce will review the survey results then determine next steps.
