SCHOLARSHIP OVERVIEW:

The State Bar of Nevada's Diversity Committee grants two \$5,000 scholarships each year to University of Nevada Las Vegas' Boyd School of Law students who embrace the Committee's mission to increase diversity within the membership and leadership of the State Bar of Nevada and the profession and to promote cultural competence. Scholarships are awarded based on merit with equal consideration given to financial need, demonstrated potential for leadership, and academic excellence. Primary consideration will be given to applicants whose essay responses best represent the Committee's mission.

The Diversity Scholarship is open to all full and part-time Boyd School of Law students. Preference is given to those students who attended the University of Nevada Las Vegas or the University of Nevada Reno for undergraduate studies, a Nevada high school, and/or to students who have been Nevada residents for 5 years or longer.

SCHOLARSHIP AWARDS:

Winners of the Diversity Scholarship will be individually notified by May 3, 2013 and formally announced at a date and location to be determined. Scholarship awards will be granted directly to the selected Boyd School of Law student in two installments of \$2,500 to be paid at the beginning of the 2013 fall and 2014 spring semesters.

Members of the Diversity Committee Scholarship Subcommittee will make all final determinations for award recipients. The State Bar of Nevada reserves the right to publicize the names of the scholarship winners and portions of the application submission, including the Diversity Essay.

SUBMISSION INSTRUCTIONS/DEADLINE:

In addition to the completed Diversity Scholarship Application, include the following items:

- ✓ Unofficial undergraduate transcript from each school attended
- ✓ Unofficial Boyd School of Law transcript (if applicable)
- ✓ Brief resume including education history, work experience, and any other pertinent information such as community involvement and publications.

Do NOT submit the following items with your application: photographs of yourself, supplemental writing samples, or letters of recommendation. They will not be considered.

The deadline for the submission of the Diversity Scholarship Application and supporting documentation is **April 22, 2013** at 5:00 p.m. Late applications will not be accepted. Submissions must be made electronically with all documentation contained in one email to lisam@nvbar.org.
