## The Reduced Fee Panel...How Does It Work?

### I. WHO CAN SIGN UP?

Every licensed Nevada attorney in good standing may sign up by completing the enclosed application. If you are not already a member of the State Bar's Lawyer Referral & Information Service (LRIS), please also include proof of errors and omissions insurance coverage of \$250,000 per claim, with \$500,000 aggregate limits.

### II. IN WHICH AREAS OF LAW MAY I CHOOSE TO RECEIVE REFERRALS?

Participating attorneys may choose from the panels described below. Note: Family Law and Bankruptcy are experience panels only.

**FAMILY LAW PANEL:** Includes all matters related to advice and handling of civil proceedings involving annulment or dissolution of marriage, custody, change of name, advice and preparation of settlement agreements, adoption, guardianship and related family transactions.

**BANKRUPTCY PANEL:** Includes all matters related to debtor/creditor problems involving insolvency, unmanageable debts, and bankruptcy.

**TENANT LAW PANEL:** Includes all matters related to real property possession problems, including collection of rent where eviction is involved.

**CONSUMER LAW PANEL:** Includes all matters related to contracts for purchase of goods, repair of goods and creditor collections and debtors defense.

### III. MAY I LIMIT THE FREQUENCY OF REFERRALS RECEIVED?

Yes. Simply indicate on the enclosed application any limitations you desire regarding the frequency of referrals.

### IV. HOW ARE THE CLIENTS SCREENED?

Clients are pre-screened by the LRIS staff over the phone. Clients may earn up to 300% of the federal poverty guidelines and be eligible. In addition these clients are required to sign a declaration of income and assets before retaining the attorney. If the client's declared income or assets are later revealed to be false or inaccurate, the client will be liable retroactively for the full fees due the attorney for actual services provided.

### V. HOW ARE ELIGIBLE CLIENTS REFERRED TO ME?

Once the clients meet the income and asset eligibility guidelines, they are referred by the LRIS staff to participating attorneys on a rotational basis, depending upon the type of legal problem and geographical area. The client will then call the referred attorney to schedule an initial consultation.

### VI. WHAT HAPPENS IF I HAVE A CONFLICT OF INTEREST?

Subject to existing obligations to the client and to the court, a participating attorney will refer the client back to the LRIS staff if he/she decides not to handle the client's matter or if a conflict of interest arises.

### VII. WHAT AMOUNT MAY CHARGE THE CLIENT IN THIS PROGRAM?

Participating attorneys may charge up to \$25.00 for the initial 30-minute consultation or they may waive the fee at their discretion. After the initial consultation, participating attorneys may charge Reduced Fee Panel clients reasonable attorney's fees (including fees for support staff) up to a maximum hourly rate of \$75.00. In order to avoid confusion, the Reduced Fee attorney and client are required to reduce any fee agreement to writing.

### VIII. WHAT'S IN IT FOR ME?

Besides satisfying the pro bono goals of the Nevada Supreme Court Rule 191, participating attorneys will be given awards annually in recognition of exceptional efforts that exemplify the spirit of public service through participation in this program.
