RHONDA L. MUSHKIN

Rhonda L. Mushkin is a partner in the Las Vegas Law Firm of Mushkin, Mushkin & Hafer. She has practiced solely in the area of domestic relations for the past seven years. Her emphasis entails both family law and adoption practice.

Rhonda is a product of the Southwest, having graduated from the Arizona State University in 1977, and the Southwestern University, School of Law in Los Angeles, California in 1984. Rhonda has law clerked for a Federal District Court Magistrate, the Clark County District Attorney, Appellate Division, and a Clark County District Court Judge prior to entering the private practice of law.

In addition to being a member of the Executive Council of the Family Law Section of the Nevada State Bar, Rhonda is the Chairperson of the Clark County Bench-Bar Committee and the Vice Chairperson of the Nevada Law Foundation. She is also a member of the Specialization Study Committee of the Nevada State Bar, and one of only two Nevada members of the American Academy of Adoption Attorneys.

In the adoption arena, Rhonda has worked closely with private placement

agencies, as well as the Department of Child and Family Services to work to revise and improve the Nevada Revised Statutes pertaining to adoptions. In the divorce arena, Rhonda has participated in the Family Court Core Committee and Rules Committee in designing the now functioning Family Court. She has an active practice in contested divorce, child custody actions and adoptions.

The vast majority of her time outside of the office is filled with the activities of her family and with competitive golf tournaments. Rhonda is presently the club champion of the Las Vegas Country Club where she plays to a six handicap.

Profiles from p. 1**FRANCES-ANN FINE STARMER**

Fran has served on the Family Law Council since shortly after our 3rd Annual Spring Showcase in Tonopah, Nevada or in the Spring of 1991.

She moved to Las Vegas in the summer of 1983 from San Francisco, California following a peripatetic lifestyle.

Fran grew up in Cleveland (is that in the United States?), Ohio. Her family moved to Arizona when she was 11 years old. They moved back and forth between Phoenix and Tucson. Fran graduated from the University of Arizona in December of 1973.

Fran moved to Washington, D.C. in early 1974 when she thought perhaps then Secretary of State, Henry Kissinger, might need help in international affairs. Unfortunately, he disagreed. Hence, Fran's birth into the legal system. Needing to eat, she obtained a position with a Washington law firm as a Legal Secretary.

Anyway, the case was then going to trial after all of his pretrial appeals had

been exhausted and they needed a secretary/ paralegal/litigation assistant. You guess it. Fran got the job and off she went to San Francisco to ready the then nine year old file for trial.

During her stay in San Francisco, she applied to Law School and the rest is history. We are right back where we started.

Upon Fran's arrival in Las Vegas, she clerked for the United States Attorney for one year, clerked for some private firms for another and once passage of the Bar had been accomplished Fran began practicing family law. Family law was what she enjoyed the most (she also did the best in her family law classes, if you must know).

Since moving to Las Vegas Fran has become active in the community both professionally and personally. She is a member of the American Bar Association, Family Law Section; Nevada Bar Association, Family Law Council; Nevada Trial Lawyers Association; Southern Nevada Association of Women Attorneys; Nevada Council of Juvenile and Family Court Judges; and American Judges Association.
