Online and Mobile Lectures

There is no extra charge to watch lectures online or through our Mobile app. All lectures and workshops will be online before the classroom course begins. You can also access and download the same lectures through our app for Apple and Android.

Written Materials

Lectures

Lectures on every subject covered on the Nevada Bar Exam are given by law school professors and nationally renowned scholars. MBE Multistate Workshops

At no extra charge, the course includes the following:

- **MBE Preview:** Offered online to be completed before the core course begins, it features practice testing, and a step-by-step explanation of all the answers. Students will be able to build upon strengths and improve upon weaknesses *before* the course.
- **MBE Drills:** Integrated during the course, it is designed to reinforce the most frequently tested topics on the MBE.
- **Simulated MBE:** Finishing the course, it culminates all MBE skills into one test-taking experience. The workshop features the nation’s most realistic simulated MBE combined with individualized computer feedback and a topic-by-topic exam analysis led by BAR/BRI MBE experts.
