14 *arbitration, or clients' security fund matters pending and (b) is current on all*  
15 *membership fee payments and other financial commitments relating to the*  
*member's practice of law in Nevada. Such resignation shall become effective when*  
*filed with the state bar, accepted by the board of governors, and approved by the*  
*supreme court.*
