#### PRESIDENT'S REPORT

Alan Lefebvre discussed the importance of continuity in leadership of the Board of Governors. Mr. Lefebvre presented a synopsis of the leadership roles of the Board.

Mr. Lefebvre appointed a taskforce charged with researching a civility rules in Nevada. Richard Scotti, Julie Cavanaugh-Bill, Ryan Russell, Elizabeth Brickfield, Paola Armeni and Richard Dreitzer were appointed to the taskforce.

Frank Flaherty reported on the short trial program in the Second Judicial District. As set forth in the Short Trial Rules the State Bar appoints a member of the Board of Governors to be on the committee for the selection of short trial judges. It was moved, seconded and carried to appoint Paul Matteoni as a member of the Short Trial Selection Committee with Larry Digesti as the alternate.

Alan Lefebvre discussed the resignation and acceptance of the resignation of Coe Swobe as the Lawyers Concerned for Lawyers (LCL) Coordinator, effective date to be determined.

#### **EXECUTIVE DIRECTOR'S REPORT**

Kim Farmer gave an overview of the 2014 Annual Meeting that will take place at the Hyatt in Newport Beach, CA. Ms. Farmer discussed the plan to hold the 2015 annual meeting at the Hotel Del Coronado.

Kim Farmer reported on the status of the purchase of the building at 3100 W Charleston. Ms. Farmer discussed different options for the current State Bar office when we move to the new location.

# Personal Injury Specialization

Alan Lefebvre presented background information on specialization in Nevada and the request of the Nevada Justice Association to obtain input/approval for a personal injury specialization designation. The Nevada Justice Association's taskforce will develop specialization program specifics for personal injury attorneys. Gene Leverty, Larry Digesti and Eric Dobberstein volunteered to be liaisons to the taskforce. Once the specialization guidelines/requirements are developed, they will be presented to the Board for approval.

#### **Financials**

Marc Mersol presented an overview of the State Bar financial operations as of July 31, 2013. Mr. Mersol reviewed points of interest on revenues and expenses of specific departments.

# **Affordable Care Act Manual**

The Health and Insurance Law Section proposes to work with the Publications Committee to draft a new reference manual, The Affordable Care Act in Nevada. The Publications Committee recommended approval for this project. It was moved, seconded and carried to approve the development of Affordable Care Act in Nevada manual.

### **Royalties and Compensation**

The Publications Committee recommended a royalties and compensation policy that outlines fees to contributing authors and editors of the State Bar published works. After discussion, no action was taken.

#### **Mineral Law Foundation**

With the resignation of Ross de Lipkau as the State Bar representative on the Rocky Mountain Mineral Law Foundation, the Foundation requested the State Bar appoint a new representative. The Board of Governors has requested more information about the Foundation and the role of the representative of the State Bar of Nevada. No action was taken at this time.
