In making the foregoing application, I expressly agree and represent to the Supreme Court of the State of Nevada as follows:

Initial

(a) I hereby grant the unconditional right and authority to the Supreme Court of the State of Nevada, the State Bar of Nevada, its Board of Bar Examiners, the National Conference of Bar Examiners, their agents or representatives, to apply for and obtain a character report regarding all aspects of my character or fitness to practice law and consent to have an unrestricted investigation made regarding my moral character, professional reputation, and fitness for the practice of law and other qualifications for admission to practice law in the State of Nevada. _____

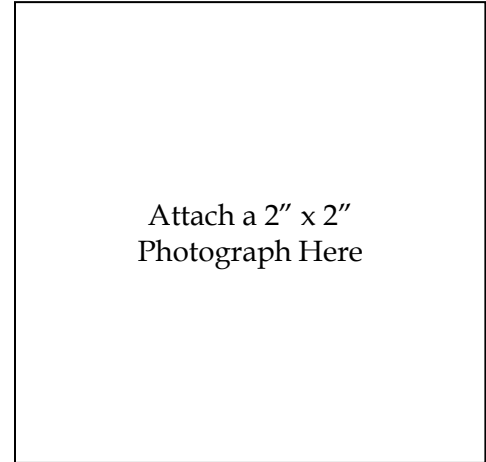
(b) I unconditionally authorize the State Bar of Nevada, its Board of Bar Examiners and Character and Fitness Committee, the National Conference of Bar Examiners, their agents or representatives, to acquire from any source any information they may request concerning my professional, academic, and character qualifications, which information may include, without limitation, implied by enumeration, confidential reports, files, records, documents, and transcripts of any type of civil, criminal, disciplinary, and/or administrative action or proceeding. _____

- (c) I unconditionally agree to give any further information which may be required in reference to my past record, conduct or condition. I understand that I will not receive and am not entitled to a copy of any character reports submitted on me or to know their content. _____
- (d) I unconditionally authorize and request every person, firm, company, corporation, governmental agency, court, state or local bar association, law enforcement agency, or other institution, having control of any documents, records and other information pertaining to me, to furnish to the State Bar of Nevada, its Board of Bar Examiners and Character and Fitness Committee, the National Conference of Bar Examiners, their agents or representatives, any such information, including documents, records, bar association files, regarding charges or complaints filed against me, formal or informal, pending or closed, or any pertinent data, to inspect and make copies of such documents, records and other information. _____
- (e) I unconditionally authorize the National Conference of Bar Examiners, or any credit bureau or other reporting agency, to submit to the State Bar of Nevada, its Board of Bar Examiners and Character and Fitness Committee, their agents or representatives, its character report on me, and I fully understand and agree that I shall not have access to said report, or to any other confidential report, and other information, except as the State Bar of Nevada, the Board of Bar Examiners or the Supreme Court of Nevada may permit. _____
- (f) I will, if asked, unconditionally authorize and request any physician, psychiatrist, psychologist, or any other person who has treated me or provided me with any kind of care, and any hospital or other institution in which I was a patient, to furnish the State Bar of Nevada, its Board of Bar Examiners and Character and Fitness Committee, the National Conference of Bar Examiners, their agents and representatives, any and all medical records and reports concerning my treatment or hospitalization for any illness, and I release said physicians and hospitals from any liabilities for furnishing same. _____
- (g) I unconditionally release, discharge and exonerate the State Bar of Nevada, its Board of Bar Examiners and Character and Fitness Committee, the National Conference of Bar Examiners, all other bar associations, and any other persons furnishing information, and their agents, members or representatives, from any and all liability of every nature and kind, in connection with the investigation into my background, the furnishing or inspection of files, documents, records, and reports relating to my character and other qualifications for admission to the State Bar of Nevada and the submission of a character report on me. _____
- (h) I hereby consent to the disclosure of all information as set forth in subsections (b), (c), and (d) pursuant to any request by any state bar, bar association, the National Conference of Bar Examiners or other admitting authority. _____
